To continue to meet the needs of our growing membership, we determined the time was right to physically expand into Green Bay.

This past summer, we opened the doors to our newly-constructed branch — at East Town Mall in Green Bay. A number of members of our team, including President and Chief Executive Officer (CEO) Nathan Grossenbach, have lived in Green Bay for years, giving us a personal knowledge of the area.





In August 2022, we cut the ribbon at the new branch. Local leaders, the Chamber of Greater Green Bay, and many others involved in the project joined us for the ceremony. It was a time for celebration as we begin serving a new market.

"I've lived in this community with my family for about 15 years now and the opportunity to bring our award-winning services to this city, and specifically this side of town, is absolutely amazing and very humbling to me . . . we look forward to serving the community for many years to come," commented President and CEO, Nathan Grossenbach.
